REQUIREMENTS:
☐ Standard Liability Insurance Policy or policies issued by a company licensed to do business in the state
for public liability covering injuries to persons and wrongful deaths from the negligence or willfulness of
the licensee, his/her agents, servants, or employees in an amount not less than \$250,000.00 for any
one person and not less than \$500,000.00 for more than one person and property damage of not less
than \$100,000.00. City of Warren must be listed as Certificate Holder/Additional Insured
☐ Surety Bond with a company authorized to do business in this state in an amount of \$5,000.00
indemnifying and agreeing to pay the City of Warren all damages, indebtedness or loss to the city
arising from any acts of omissions of the licensee or his/her agents, servants, employees or his/her
lessees or licensees, in the operation of such business.
☐ A copy of your Driver's License or State ID
