PUBLIC NOTICE CARES ACT AMENDMENT PROPOSED FOR ADOPTION CITY OF WARREN 2019-2020 ACTION PLAN 2016-2020 CONSOLIDATED PLAN

The City of Warren will receive \$126,648 in funding from the Coronavirus Aid, Relief and Economic Security Act (CARES Act) for the Housing Opportunities for Persons with AIDS Program. These funds must be used to prevent and respond to the impacts of COVID-19 in lower income persons living with HIV/AIDS (PLWH/A) in Macomb, Lapeer, Livingston, Oakland, and St. Clair Counties.

The Amended 2019 Annual Action Plan will serve as a grant application for the funds made available through the CARES Act.

Citizen Participation – Emergency Policies and Procedures

The Cares Act Amendment, also includes updates to the Consolidated Plan's Citizen Participation Plan (CPP). The CPP describes the framework through which residents can have input in the planning, implementation, coordination, and assessment of the projects and activities the City undertakes.

HUD recognizes the urgent need for cities to immediately assist local businesses and residents during the COVID-19 pandemic. They have authorized the following modifications to Consolidated Planning documents and citizen participation requirements during emergency declarations.

To expedite actions to respond to COVID-19, a 5-day comment period is implemented and replaces the regulatory 30-day public comment period requirement for Amendments to the Consolidated Plan and Action Plan during this health crisis.

The City of Warren's Citizen Participation Plan provides citizens the opportunity to: attend public meetings, to view hard copies of planning documents, and provides notice in the newspaper 10 days prior to the public meeting. In efforts to contain COVID-19, Governor Whitmer has implemented a stay-at-home order, which restricts public gatherings and non-essential travel. In response to these measures, the city modifies the CPP to implement: virtual meetings that allow citizens to comment online rather than in person, limits the availability of documents to online or in hard copy by request, and shortens the publication of notice for public hearings from 10-days prior to 5-days prior to the public hearings.

The 5-day comment period on the Draft Cares Act Amendment will be May 13, 2020 through May 18, 2020.
